

Non-EU Europe Compliance

International Approvals (IA) Vocabulary

- Local Representative (or Local Rep) An in-country agent, authorized via a Registered Letter of Authorization, to serve as an official for an importing manufacturing company
- GDP-PPP The Gross Domestic Product on a Purchasing Power Parity basis, which is found by dividing the GDP by population for each country, and is a rough measure for the economic output per capita, used in economic and marketing analysis
- WPR The World Population Ranking for each country, where the 1st is the most populous (China at ~ 1.4 billion), and the 237th is the least populated (Pitcairn Islands at 54)
- **APR** The Africa Population Ranking, ranking each African country by total number of inhabitants




- Africa is the world's 2nd largest continent, with 50 countries

Mercator Projection Map





Authagraph Projection Map (1999 – Hajime Narukawa)





Peirce Quincuncial Projection Map (1879 – Charles Sanders Peirce)



- Expect frequent new/updated regulatory requirements
 - Especially for new wireless & telecom technologies
 - Developing regulatory systems in developing market countries
- Political and social instability presents challenges
- Evaluate risks vs. rewards; investigate
 - e.g. List of African countries by GDP (PPP)
 - <u>http://en.wikipedia.org/wiki/List_of_African_countries_by_GDP</u>
 - When researching, check country domain names
 - (e.g. ".eg" for Egypt)



Africa Compliance Summary

- Join industry affinity groups to learn from other's experience
 - IEEE Societies, i.e. EMC, Product Safety Engineering
 - Linked In groups, e.g. IoT International Compliance, Wireless Certification Professionals
- Find a reliable & knowledgeable partner for testing and certifications
 - Verify test labs have required accreditations
 - Ensure country-specific deviations are documented in the required report format
 - Be sensitive to the local business customs
 - Agency contacts are critical
